Minutes of the First Meeting of the Validation Committee for the year 2013-14, (First Quarter April 2013-June 2013), held on 15/1/2013 at NLDC, New Delhi.

- The Chairman of the Validation Committee, Shri Pankaj Batra, Chief (Engg.), CERC welcomed the participants present in NLDC Conference Room and also the other participants of RPCs, RLDCs and STUs and Generating Companies present at the Conference Room of WRLDC, SRLDC, ERLDC and NERLDC through video conferencing. List of the participants is enclosed at Annexure-I.
- 2. Chief (Engg.), CERC stated that the 1st meeting of Validation Committee for the year 2013-2014 (First Quarter April 2013-June 2013) has been called to validate the expected demand, generation data and new transmission lines for the First quarter of the year 2013-2014. He stated that petitions for all transmission lines expected to be commissioned by 1st May,2013 need to filed by the third week of January . POWERGRID requested for filing petition by 31.1.2013. Chief(Engg.) stated that no petition after 31st January would be considered and POWERGRID should try to file petition as early as possible.
- 3. He stated that there would be only one more meeting of the validation committee probably by the end of January, 2013. All information should be made available by end of January. He then requested ED, NLDC to give a presentation of the Demand and Generation data along with New transmission elements and New Generation Projects coming in the First Quarter of the year 2013-2104. Transmission assets and units to be declared Commercial on or before 1st May,2013 are to be included for Q1 2013-14 Case Load flow studies.
- 4. The NLDC first gave a presentation with details of Generating units and transmission lines Commissioning, which were considered in H2 2012-13 case, but not commissioned during the pre-defined period. It was explained by Joint Chief (Engg.) CERC that if a generating station is considered in load flow and then not commissioned, it had two impacts, first the computation of POC rates got distorted and second there would be under recovery of POC charges due to their slippage. This may result in liability for DICs under bill NO. 3, which is the deviation bill. So, the correct information with respect to Generator Commissioning is in the interest of all DICs. The cases of variation in large capacity generating stations were discussed and the concerned DICs informed the reason for the same along with their latest status.

- 5. The details of Transmission lines which were included in H2 2012-13 case and could not commissioned on anticipated date was also presented. The details were prepared based on CEA website. POWERGRID was asked to submit the information within a week.
- Chief (Engg.) CERC desired that the details of these generating stations and transmission lines may be mailed to all, So that the concerned person can come ready with the answers. This would again be discussed in the next meeting.
- 7. The data presentated by NLDC was discussed with the representatives of DICs present in the meeting .The brief of the presentation and decision arrived during the discussion are given below:

- VI. Simhadri Generation is to be segregated. Unit 1&2 are dedicated for Andhra Pradesh and Unit 3&4 are ISGS for the purpose of approved injection..
- VII. Bellary unit 2 not yet stabilized. However, it is likely to be declared commercial by March 2013.
- VIII. Durgapur Steel Thermal Power Plant DVC unit 2 of 500 MW is to be considered for computation of PoC Charges and Losses for Apr'13-Jun'13 period.
- IX. ERLDC informed that GMR is an Intra State Generating Station.
 - 8. It was informed that the requisite data for load flow study as required is still not submitted by all DICs. Joint Chief (Engg.) stated that giving data for POC computation is a regulatory requirement and non compliance with this is serious. It is in the interest of DICs that correct network data is given . NLDC

informed that for correct load flow they need Node wise data and new Generating and transmission elements data. At least information of new elements is a must. It was decided that NLDC would send request through email for information within one week. If the information is not submitted by DICs, the details of those about DICs which have not submitted information will be given to Commission for further action Also it would be better if DICs submit data in PSS format, as most of them had received PSS Software from CTU.

- 9. The respective RPCs were requested to get the Commissioning schedule of Generating stations confirmed from the Developers who were not present. In case information is not available, It was decided that thermal and nuclear generators getting synchronized after 31st January 2013 should not be considered for Q1 case as COD takes place after about three months of synchronization.
- 10. Chief (Engg.), CERC stated that all the generating companies including NPCIL and other generating companies should also be issued notices for attending the meeting. Also RPCs were requested to ensure participation of all DICs in the meeting.
- 11. Chief (Engg.), CERC requested all utilities that the justifications with regard to changes in demand and generation projection are to be sent either to NLDC, with one copy to CERC in writing within one week. All RPCs/ RLDCs may coordinate with their constituents in getting realistic data.
- 12. Soft Copy of data discussed during the meeting along with presentation made during the meeting is enclosed .This includes:
 - (1) Projected Generation
 - (2) Projected Demand
 - (3) New Generation considered
 - (\$) New Transmission Lines

This was as per agenda items. The change in Demand/Generation suggested during meeting would be incorporated after written confirmation along with reasoning.
