Record of Proceedings

This petition has been filed by the petitioner, NHPC Limited for approval of tariff of Chamera-I Hydro Electric Power Station for the period 1.4.2009 to 31.3.2014 after truing up exercise in terms of Regulation 6 (1) of the 2009 Tariff Regulations and for determination of tariff for the period 2014-19 in terms of the provisions of the 2014 Tariff Regulations.

- 2. During the hearing, the representative for the petitioner made detailed submissions in the matter and prayed that tariff of the generating station may be revised for 2009-14 after truing-up and tariff for the period 2014-19 may be approved. The representative further submitted that additional information sought for by the Commission has been filed and copies have been served on the respondents. He however, prayed for grant of time to file rejoinder to the reply filed by respondent, BRPL.
- 3. The learned counsel for the respondent, BRPL referring to its reply dated 19.11.2014 made detailed submissions. Accordingly, he prayed that the revision of tariff for 2009-14 and approval of tariff for 2014-19 for the generating station may be granted in accordance with the provisions of 2009 Tariff Regulations and 2014 Tariff Regulations respectively with prudence and check.
- 4. The Commission after hearing the parties directed the petitioner to submit additional information, on affidavit, with advance copy to the respondents, on or before 15.12.2014 on the following:

- (i) Details of party-wise and component-wise un-discharged liabilities as on 31.3.2014 and as on 31st March of each year for the tariff period 2009-14 and 2014-19 (projected, if any);
- (ii) Details of assets not in use, if any;
- 5. The above information shall be submitted within the due date mentioned above. The parties shall complete the pleadings before the said date. In case the information/ rejoinder is not filed within the said date, the matter shall be considered based on available records.
- 6. The Commission reserved its order in the petition.
