<u>ORDER</u>

Regulation 7 (n) of the Central Electricity Regulatory Commission (Procedure, Terms and Conditions for grant of trading licence and other related matters) Regulations, 2009 as amended from time to time (Trading Licence Regulations) provides for obligations of the licensee as under:

"7 (n). The licensee shall not omit or neglect to undertake trading activity."

2. Regulation 14 of the Trading Licence Regulations further provides as under:

"14. Revocation of Licence: (1) The Commission may revoke the licence, in any of the following circumstance, namely:

- (e) Where the licensee has neglected to undertake trading in electricity."

3. As per the above provisions of the Trading Licence Regulations, the licensees are required to undertake trading in electricity and failure to undertake trading in electricity will render the licences liable for revocation. It has been observed that the respondents/ Trading Licensees are not undertaking trading in electricity as per the details given in the appendix. The respondents are directed to explain, latest by 16.9.2014, the reasons for not undertaking trading in electricity enabling this Commission to take a view whether the licenses granted should be revoked or not done to failure to undertake trading in electricity.

4. The petition shall be listed for hearing on 30.9.2014.
