The sealed offers should be superscribed as "Offers for Supply of potted Indoor Green Plants". The sealed offers should reach by Friday, the 19th September, 2014 before 3.00 p.m. The offers will be opened on the same day at 4.00 p.m. The CERC reserves the right to accept or reject any offer without assigning any reason whatsoever.
- 4. The terms and conditions are as follows:
 - a) The supplier will maintain all the plants by everyday watering, cleaning pruning, trenching, spraying of insecticides etc.
 - b) The supplier will supply healthy indoor variety plants as mentioned above in plastic pots.

- c) A random check will be conducted to inspect the freshness, quality and quantity of Green Plants. The decision of hospitality official in this regard will be binding on the contract holder.
- d) The aforesaid Plants/material shall be stricitly as per spcifications and contractor shall be responsible for freshness of material supplied.
- e) No advance payment will be made in any case. Payment will be made every month after production of bills.
- f) The Party will supply the plants on rotation basis i.e. the plants are to be replaced on fortnight basis so that the quality and freshness of the plants can be maintained. The CERC will not pay any extra charge for transportation of plants, replacement or rejection.
- g) The period of contract will be for a period of one year from the date of award of contract which can be extended for two more years. An escalation of 10% may be considered on annual basis at the discretion of the competent authority depending upon the performance of the supplier.
- h) The CERC shall be at liberty to terminate the contract if not satisfied with the quality of plants supplied by the supplier and in case of breach of conditions of the contract.
