1. Scope of Assignment:

The Central Electricity Regulatory Commission invites bids in sealed cover for supply, installation and configuration of four numbers of 22"HD Touch Creative Pen Display as per specifications mentioned in *Annexure-A*.

CERC reserves right to place a repeat order with in the validity of the offer, at the same rates, terms and conditions.

2. Objective

To enable the Commission to access Digitized case portfolio of petition in the Court Room during hearing and to facilitate writing up of their observations/notes as annotations/ comments using stylus Pen on the touch creative screens under document writing.

3. Deliverables

- 3.1 Supply of Items as per ***Annexure -A within 15 (fifteen) days from placement of order.***
- 3.2 Installation, Configuration, implementation, testing, training and successful demonstration of supplied items within two days from the supply.
- 3.3 User Manuals and Training Manuals to be supplied along with the machines.
- 3.4 One year on-site warranty for repair.

4. Eligibility Criteria of Bidders:

- 4.1 The Bidder should be a company or corporation registered under the Companies Act 1956 in the business of supplying HD Touch Creative Pen Display.(Bidder should attach Registration Certificate)
- 4.2 A Bidder should be manufacturer or authorized distributor/channel partner of the required HD Touch Creative Pen Display.(Bidder should attach Manufacturer's Authorization Form)

- 4.3 The Bidder should have a valid PAN/TAN Numbers and Service Tax Registration Number. (Kindly enclose documentary proof).
- 4.4 The bidder should have successfully commissioned at least three similar projects in Government/ Government Organizations/Organizations of repute of same OEM's equipment during the last three years. (An undertaking on company letter head along with the references of these clients should be submitted)
- 4.5 The Bidder should have never been black-listed for any reason in any Government organizations in last three years.(An undertaking on company letter head as per **Annexure- B** should be submitted)

5. Bidding Procedure and Bid Security (Earnest Money) :

Bid Security (Earnest Money):

- 5.1 The technical bid shall be accompanied by an Earnest Money Deposit of Rs. 50,000/- (Rupees Fifty Thousands only) in the form of Pay Order/Demand Draft in favour of the "Assistant Secretary, Central Electricity Regulatory Commission", payable at New Delhi, in a separate sealed envelope.
- 5.2 EMD of unsuccessful bidders will be returned without any interest within one month after tender finalization. EMD of the successful bidder will be treated as security deposit and released on receipt of material at site.
- 5.3 The Bid Security (Earnest Money) may be forfeited:
 - i. if a Bidder withdraws his bid during the period of bid validity; or
 - ii if at any stage any of the information/ declaration is found false.
- 5.4 Bids not accompanied by Earnest Money would be summarily rejected.

6. Period of Validity of Bids:

Bids shall remain valid for **Three months from** the date of Bid opening. A bid valid for a shorter period may be rejected by the Commission as non-responsive.

7. Bid Submission

Bids are invited in two bid system – (i) Technical Bid and (ii) Financial Bid

7.1 The bid is to be submitted in three envelopes as follows:

i) ENVELOP-01: Containing eligibility documents and Draft for EMD of Rs. 50,000/-. The envelope should be sealed and superscripted as “Eligibility Bid and EMD for Supply of 22” HD Touch Creative Pen Display”.

ii) ENVELOP-02: Containing documents establishing the technical criteria as per forms 1-2 of **Annexure- C**. The envelope should be sealed and superscripted “Technical Bid for Supply of “22” HD Touch Creative Pen Display ”.

The technical bid envelope should not contain any explicit or implicit information with regard to the rates otherwise the bid shall be liable to be rejected.

iii) ENVELOP-03: Containing financial bid as per **Annexure-D**. The envelope should be sealed and superscripted “Financial Bid for Supply of 22” HD Touch Creative Pen Display”.

iv) All the three envelopes i.e. the envelope containing Technical Bid along with EMD and the envelope containing Financial Bid should be sealed in an outer cover duly superscripted “BID for Supply of 22” HD Touch Creative Pen Display”

v) The cover may be submitted by the due date and the time as mentioned above, at the following address:

7.2 Each page of bid should be numbered and signed by the authorized signatory with the seal of the firm.

8. Opening of Bids:

8.1 The Technical bids will be opened in the presence of representatives of bidders, who may be present at the time of bid opening. The representative shall append his signature, on the attendance sheet provided, in token of having attended the Bid opening.

8.2 The envelopes EN-03 containing Financial Bids of the only technically qualified bidders shall be opened at the time of Financial Bid opening, subject to the condition as mentioned in col. 9.1.

9. Evaluation of Bids:

9, 1 The Bids will be evaluated on combined score of technical and financial criteria 50% weight age will be given to technical bid and 50% to financial bid. Minimum of 30 score (out of 50) will be necessary for qualifying in technical bid evaluation. The financial bids of only those bidders would be opened who score this minimum score in technical evaluation.

9.2. Technical evaluation will be done on the basis of the following criteria:

9.3 L1 would be allotted full 50 points and other bidders would be allotted lower points on inverse proportion based on their financial bids.

10. General Terms and Conditions

10.1 CERC reserves the right to accept or reject any or all bids in part or full, at its absolute discretion without assigning any reason what so ever or without any further notice in this regard.

10.2 For any doubt or clarifications regarding current IT setup and infrastructure, the Bidders are welcome to contact Ms Vaishali Rana over telephone (011-2335 3503, Extension No. - 446) between 10:00 am to 5:00 pm, Monday to Friday.

10.3 CERC reserves the right to forfeit the EMD amount on non-acceptance/non-compliance to the terms of offer in full or part or if CERC finds that Bidder has misrepresented in any way while tendering the bids.

10.4 The items can be supplied by the manufacturer directly or through their authorized dealer /authorized channel partners/distributors.

10.5 The CERC may reject all or any of the condition that may be stipulated by the Bidder while bidding.

- 10.6 Canvassing in any form will be viewed seriously and if any Bidder is found to be resorting to such practices, the Bid of such firm shall be liable to be rejected.
- 10.7 Items shall be delivered and installed at Central Electricity Regulatory Commission, Third and Fourth Floors, Chanderlok Building, 36, Janpath, New Delhi – 110 001. **No separate installation/ cartage/ transportation charges/overheads etc shall be payable.**
- 10.8 In the event of any ambiguity during the examination, evaluation and comparison of bids, CERC may at its discretion ask the bidders for clarification of its bid on any point. The clarification, response of the bidder, to any query that may be made by CERC shall be in writing and shall have to be furnished within the time frame as may be stipulated in the CERC communication.
- 10.9 Successful Bidder will have to strictly adhere to the delivery schedule and other terms and conditions relating thereto, failing which CERC may get the work completed at the risk and the cost of the supplier from another supplier. Further in such circumstances the CERC reserves the right to cancel the purchase order and forfeit the EMD/Bank Guarantee.
- 10.10 The supplier shall furnish a Performance Security equal to the 5% of the value of the contract. Performance Security may be furnished in the form of Bank Guarantee/Fixed Deposit Receipt/Account Payee Demand draft for a period of sixty days beyond the date of all contractual obligations of the supplier including warranty obligations.
- 10.11 Payment terms: 95% payment shall be released on successful and satisfactory installation, testing, training and acceptance of hardware and related set up by the representative Engineer of the supplier and the authorized representative of the Commission. Balance 5% shall be released against the submission of performance security as in the previous para.

- 10.12 CERC reserves the right to accept or reject all or any of the offers without assigning any reason what so ever.
- 10.13 Any disputes arising out of this bidding process shall be under the jurisdiction of courts/tribunals in Delhi only.
- 10.14 The Commission shall not be responsible for any loss or damage to any Item in the event of Force Majeure conditions during transit/installation process.
- 10.15 The Bids received after the due date shall not strictly be entertained.
- 10.16 The tender document is available on the CERC website <http://www.cercind.gov.in>.
- 10.17 The supplier/manufacturer shall provide free on-site warranty for a period of at least one year. Preference shall be given to supplier/ manufacturer providing warranty for more than one year. During on-site warranty the complaints should be attended within 24 hours and rectification should be carried out within 48 hours except when parts are not available. In no condition the period should exceed seven days, otherwise a stand-by equipment should be provided.
- 10.18 The bidder will provide a guarantee that the rates quoted are minimum rate and he will not supply within three months these items to any other organization at rate below agreed rate with CERC. Failing to do so, will be liable to reimburse the difference between the rates charged from CERC and other buyers.

11. Liquidated Damages:

Fully functional solution would be demonstrated to the selected group of Officers of CERC. Any delay beyond the time mentioned in work order will attract a liquidated damage at the rate of 0.5% of the total value of the work order per day of delay subject to a maximum of 10% of the supply order.

Beyond that, CERC may cancel the supply order and get the supply completed from alternate sources at the risk and cost of the vendor.
