## **Interim Order**

This application has been made by the petitioner, Power Grid Corporation of India Limited , for review of order dated 20.5.2015 in Petition No 109/TT/2013, whereby the Commission had determined the transmission tariff for 240 MVAR Bus Reactor at Agra (COD: 1.1.2013) under Common Scheme for 765 kV Pooling Stations and Network for NR, Import by NR from ER and Common Scheme for network for WR and Import by WR from ER and from NER/SR/WR via ER in Northern Region for tariff block 2009-14 in terms of the Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2009.

- 2. Aggrieved by the said order dated 20.5.2015, the learned counsel for the petitioner submitted that there are certain errors apparent on the face of the order and sought review on the following issues:
  - a) Condone the time over-run of four months and allow the deducted IDC/IEDC of ₹70.67 lakh on account of delay;
  - b) Allow the cost of ₹1489 lakh on account of additional land compensation for Agra sub- station; and
  - c) Allow the interest for the period from 1.1.2013 to 13.5.2013.



- 3. Heard the learned counsel for the petitioner on 'admission'. Admit and issue notice to the respondents.
- 4. The petitioner is directed to serve the copy of the review petition along with this order on the respondents by 24.2.2016. The respondents shall file their replies by 8.3.2016, with copy to the petitioner, who shall file its rejoinder, if any, by 14.3.2016. The parties shall ensure the completion of the pleadings within the due date mentioned and no extension of time shall be granted for any reason whatsoever.
- 5. Petition shall be listed for hearing on 22.3.2016.
