Note- The work of dismantling, removing and refilling of malba has been awarded separately and thus not to be included in labour charges.

- 3. Bidders shall have experience of having done similar jobs for other clients. Eligibility of the bidder shall be decided based on past experience of the agency for similar job.
- 4. The prices should be inclusive of cartage and transportation of goods etc. CERC will not pay any extra charges for cartage and transportation of goods. Service tax and VAT, if any shall be payable extra.
- 5. The agency is required to complete work within 45 days from the date of award of contract.
- 6. The quality, colour and style of the tiles/wash basin should match with the existing tiles/wash basin etc.
- 7. Before quoting the rates, the bidders can also inspect the site on any working day from 01 Sep, 2016 to 09 Sep, 2016 between 10.00 AM to 06.00 PM.
- 8. **TOOLS and EQUIPMENTS -** The agency shall arrange at its own expenses all necessary tools, equipments and required parts for proper execution of the work.
- 9. **SATISFACTORY SERVICES** The decisions of Assistant Secretary (P&A), CERC or any other officer authorized by the Secretary, CERC, shall be final and binding on the firm / agency for the purpose of determining satisfactory services.
- 10. **PROHIBITION OF SUB CONTRACT -** The firm / agency shall not appoint any sub-contract for this work under any circumstances.
- 11. The payment shall be released through RTGS on satisfactory completion of entire work. No advance payment will be made in any case.
- 12. **DEDUCTION OF INCOME TAX AT SOURCE -** Since it is a "Works Job Order", Income Tax shall be deducted as source from all the accepted payment to be made, in accordance with the provision of Income Tax Act, 1961 as amended from time to time.
- 13. **RESOLUTION OF DISPUTE** In case of dispute the decisions of Secretary, CERC shall be final.

14. Penalty Clauses:-

(a) **Deficiency in quality**: In case of failure on the part of agency or delay in completion of work, the CERC shall have the discretion to get it rectified/ completed from other sources at contractor's risk and cost.

15. **Earnest Money Deposit:**

- (i) The bidder shall submit (along with the technical bid) an Earnest Money Deposit of Rs. 8,000/- (Rupees Eight Thousands only) in the form of a demand draft/Bankers Cheque drawn in favour of Assistant Secretary, Central Electricity Regulatory Commission, New Delhi.
- (ii) EMD of unsuccessful bidder shall be returned to them at the earliest.
- 16. Quotations strictly as per the above specification may kindly be sent to the undersigned in sealed cover on or before Friday, the 16 Sep, 2016 up to 13.00 P.M. Quotations will be opened on the same day at 14.00 P.M.
- 17. The Secretary, CERC reserves the right to accept or reject any or all the quotations without assigning any reason whatsoever.
