Description of Work

1. The bidder shall be responsible for maintaining the electrical items of CERC with the help of full time qualified Electrician with one helper to be posted in CERC's office. The Electrician to be posted at CERC should be experienced electrician having minimum five years experience in maintenance of electrical items in any office of Government Departments/PSUs. Documents in support of the qualification and experience needs to attached.

Terms and Reference and Scope of Contract

2. One full time electrician with one helper shall be deployed in CERC by the Contractor from 09.00 AM to 06.00 PM on Mondays to Saturdays. He shall be responsible for all preventive maintenance of the electrical items of CERC and fault rectification. All tools required for the job has to be arranged by the contractor. Materials for replacement of parts will be provided by CERC.

2.1. **SUBMISSION OF TENDER –** The tender must be submitted in the prescribed pro-forma provided in Annexure – I and Annexure – II. Tenders not in the prescribed pro-forma are liable to be rejected.

2.2 The bidder is required to supply the consumables items as per requirement of this office. List of electrical consumables required by this office is attached at Annexure-III.

Minimum Wages

3. The contractor would make payment of minimum wages, as notified by the Ministry of Labour and Employment, Government of India, as notified from time to time and produce evidence, in support thereof, if required.

Escalation

4. As and when, Ministry of Labour and Employment, Government of India revises the minimum wages, the enhancement of minimum wages would be allowed as escalation.

EMD/Bid Security

5. The contractor would furnish Earnest Money Deposit (EMD) of ₹ 10,000/through Demand Draft/Pay order payable to Assistant Secretary, CERC which shall be refunded to the unsuccessful bidders on finalization of contract.

Security Deposit

6. The successful bidder would be required to deposit ₹ 25,000/- as interest free security deposit which shall be refunded on completion of the contract.

Tenure of Contract:

7. The period of contract shall be for a period of one year, which may be extended on yearly basis up to maximum of two more years as agreed upon at the discretion of the competent authority. CERC reserves the right not to extend the contract without giving any reason what so ever.

Terms of Payment:

8. On monthly basis on satisfactory completion of duties/work.

9. Incomplete offer/failure to comply with any of the above requirements shall make the bid liable for rejection.

10. The interested bidders may inspect the site for assessment of exact quantum of work before quoting after fixing up appointment with the undersigned.

11. Termination of Contract: CERC reserves the right to terminate the contract by giving one month advance notice in case CERC not satisfied with the quality of service, provided.

The bidders are requested to submit technical and financial bids in two separate envelopes as per format attached at Annexure I and II.
