ORDER

Instant Review Petition has been filed by Power Grid Corporation of India Ltd. (PGCIL) against the Commission's order dated 20.9.2017 in Petition No. 272/TT/2015 wherein transmission tariff in respect of four assets, namely, (a) 315 MVA 400/220 kV ICT-I and associated bays and 03 Nos. 220 kV line bays at Saharanpur Sub-station, (b) 315 MVA 400/220 kV ICT-II and associated bays and 03 Nos. 220 kV line bays at

Saharanpur Sub-station, (c) 50 MVA, 400 kV Bus Reactor-I at Saharanpur Sub-station

and (d) 50 MVA, 400 kV Bus Reactor-II at Saharanpur Sub-station was allowed.

2. Learned counsel for the Review Petitioner has contended that denial of cost for 4

nos. line bays of 220 kV at Saharanur, non-consideration of RCE submitted vide

affidavit dated 14.6.2017 and restricting the capital cost to FR are erroneous and

constitute error apparent on the face of record. He requested to modify the order dated

20.9.2017 by allowing the cost of 4 nos. line bays of 220 kV at Saharanur and

considering the RCE submitted in the main petition.

3. We have considered the submissions of the Review Petitioner. We admit the review

petition and direct to issue notice to the Respondents.

4. The Review Petitioner is directed to serve copy of the review petition on the

respondents by 14.3.2018. The respondents are directed to file their replies by

10.4.2018 and the Review Petitioner to file rejoinder, if any, by 20.4.2018. The parties

are directed to comply with above directions within the timeline specified. No extension

of time shall be granted.

5. The Review Petition shall be listed for hearing on 8.5.2018.
