ORDER

Learned counsel for the Review Petitioner submitted that Review Petition Nos. 20/RP/2018 and 3/RP/2019 emanate out of the order dated 22.2.2018 in Petition No.13/TT/2017 and order dated 6.11.2018 in Petition No.205/TT/2017 wherein the Commission determined the tariff of Champa-Kurukshetra HVDC Pole-I and Pole-II respectively. She further submitted that Petition No. 142/MP/2019 has been filed by KSK Mahanadi Power Limited wherein the methodology followed by the Review

Petitioner for billing of Pole-I and Pole-II of Champa-Kurukshetra corridor has been sought to be modified.

- 2. Learned counsel for the Review Petitioner submitted that in compliance of Commission's direction, they have served copies on all the respondents who were parties in Review Petition No. 20/RP/2018.
- 3. Learned counsel further submitted that though the Commission vide its order dated 9.5.2019 has admitted Review Petition No. 3/RP/2019 and directed to issue notice to the respondents but the respondents are yet to be served. She further submitted that any order passed by the Commission in Review Petition No. 20/RP/2019 will apply to Review Petition No. 3/RP/2019 as well. She submitted that receivables of the Review Petitioner in the case of Champa-Kurukshetra HVDC Pole-I and Pole-II are mounting as the respondents are being billed provisionally which in turn is resulting in underrecovery and requested for early hearing of Review Petition Nos. 20/RP/2018 and 3/RP/2019.
- 4. Learned counsel appearing for TRN requested for adjournment due to unavailability of their main arguing counsels due to personal difficulties.
- 5. Learned counsel appearing for M.B. Power (Madhya Pradesh) Limited submitted that IA No. 48 of 2019 was filed on 2.5.2019 for impleadment of M.B. Power (Madhya Pradesh) Limited but the Commission in its order dated 13.5.2019 has inadvertently recorded that no such application was filed. She urged that M.B. Power (Madhya Pradesh) Limited may be impleaded in Review Petition No. 20/RP/2018 and the

Commission's order dated 13.5.2019 in Review Petition No. 20/RP/2018 regarding billing may also be made applicable in its case.

- 6. We have considered the submissions of MB Power (MP) Ltd. It is observed that MB Power (MP) Ltd. has filed an application for impleadment, besides other prayers, on 2.5.2019 and the same was mentioned during the hearing on 2.5.2019. The said application was under scrutiny and it was not registered. Hence, in order dated 13.5.2019, it was inadvertently observed that MB Power (MP) Ltd. did not file the application for impleadment. The Interlocutory Application No.48/IA/2019 filed by MB Power (MP) Ltd. for impleadment is allowed. Further, the relief granted to TRN Energy Ltd. in order dated 13.5.2019 is also extended to MB Power (MP) Ltd.
- 7. Learned counsel for Maruti Clean Coal and Power Limited (MCCPL) has submitted that Interlocutory Application No. 49 of 2019 has been filed for its impleadment in Review Petition No. 20/RP/2018. He submitted that the Review Petitioner be directed to revise the POC bills issued by it from April, 2018 linking it with operationalization of LTOA for MCCPL with the date of commercial operation of 765 kV D/C Jabalpur-Orai transmission line from which the LTOA was originally sanctioned and BPTA was signed. We have considered the submissions of MCCPL. MCCPL is impleaded as respondent.
- 8. The Commission's order dated 13.5.2019 regarding billing shall be applicable to all the generators, IPPs and beneficiaries. This billing and payment mechanism will continue till the outcome of the present Review Petitions.

- 9. We direct the Review Petitioner to serve all the respondents in Review Petition No. 3/RP/2019 as expeditiously as possible and the parties are directed to complete the pleadings by 29.5.2019.
- 10. The e-filing window of the Commission in Review Petition Nos. 20/RP/2018 and 3/RP/2019 shall remain open till 6.00 p.m. on 29.5.2019. The timeline indicated by the Commission vide its order dated 9.5.2019 in Review Petition No.3/RP/2019 for completion of pleadings stand modified accordingly. The parties are directed to comply with the directions within the specified timeline and no extension of time shall be granted.
- 11. Petition Nos. 20/RP/2018 and 3/RP/2019 be listed for hearing on 30.5.2019 at 3.00 p.m.
