4. The detailed terms and conditions are as follows:-

(a) The supplier will be required to install /provide five numbers of cold, Hot & normal water dispensers free of cost in CERC. Successful performance of the same will be the responsibility of the supplier.

(b) No security deposit will be deposited with the firm by the CERC for the bottles.

(c) The water should be supplied on every working day or as required. The firm should ensure that the delivery of the jars should reach latest by 10:00 A.M.

(d) The firm should also ensure to get the day to day supply voucher signed by the different section of this office.

(e) The payment shall be made on monthly basis on receipt of the bills and checking of day to day supply receipts. No advance payments shall be made under any circumstances.

(f) Prices should be inclusive of all taxes, duties and cartage. The prices will remain fixed throughout the contract period irrespective of any changes made in statutory levies by the Government.

(g) The Contractor will be obliged to replace the empty bottle with the filled ones as and when required under a continuous process. No additional charges in respect of cost/rent /deposit for the bottles or dispensers will be entertained.

(h) The contract will be for a period of one year which can be extended for two more years at the discretion of the competent authority, depending on the performance of the supplier.

5. The CERC shall be at liberty to terminate the contract:-

(a) If not satisfied with the fitness of bottles or dispensers and purity of water supplied by the supplier. In such a case the CERC will have option to procure water from alternate supplier at the cost and responsibility of the contractor.

(b) The CERC will have full rights to terminate the contract and award any portion of the supplies to any other agency at any stage in case of any breach of conditions of the contract.
