Scope and description of Works: -

2. To undertake repair/ replacement of damaged parts of VRF air conditioning system. List of parts replaced is as given below: -

- 3. The agency shall be responsible for rectifications of the air-conditioners.
- 4. The agency shall be responsible for attending breakdown calls during the contract period and fault rectification on-site as well as off-site and refrigerant gas charging as and when required.
- 5. The unit charges for repair and replacement of inverter/ constant compressor and filling of refrigerant gas should be furnished separately. The charges for the same shall be payable depending upon the quantity. Warranty of the inverter/ constant compressor should be for a minimum period of three months from the date of purchase.

- 6. On receipt of a break down intimation, a qualified and competent team would be deputed immediately so as to ensure that Air Conditioners are functioning satisfactorily.
- 7. The agency shall depute skilled operator on need basis as per minimum wages rate of Central Govt.
- 9. The bidders may inspect the HVAC system and satisfy themselves about the condition of air conditioning system and its components before quoting their rates.
- 10. **TOOLS and EQUIPMENTS: -** The agency shall arrange at its own expense all necessary tools, equipment and required parts which are required for proper execution of the work.
- 11. **TENURE OF CONTRACT:-** The tenure of the contract shall be initially for three months. The period of contract may be extended, if required.
- 12. The competent authority reserves the right to terminate the contract at any time before completion of the tenure in case the services of the firm are found unsatisfactory, and without assigning any reason what so ever.
- 13. **SATISFACTORY SERVICES: -** The decisions of Assistant Secretary (P&A), CERC or any other officer authorized by the Secretary, CERC, shall be final and binding on the firm / agency for the purpose of determining the standard of satisfactory services.
- 14. **PROHIBITION OF SUB CONTRACT:-** The firm / agency shall not appoint any sub-contract for this work under any circumstances.
- 15. The payment for replacement of compressors, gas filling etc. shall be based on units rate quoted.
- 16. **DEDUCTION OF INCOME TAX AT SOURCE: -** Since it is a "Works Job Order", Income Tax shall be deducted at source from all the accepted payment to be made, in accordance with the provision of Income Tax Act, 1961 as amended from time to time.
- 17. **RESOLUTION OF DISPUTE: -** In case of disputes the decisions of Secretary, CERC shall be final.
- 18. The Secretary, CERC reserves the right to accept or reject any or all the quotations without assigning any reason what so ever.
- 19. **Submission of tender:** The tender must be submitted in the prescribed proforma provided in **Annexure-I**.
