In regard to the Hon'ble CERC notice dated 03.03.2025 inviting comments/ suggestions/ objections on Draft Central Electricity Regulatory Commission (Connectivity and General Network Access to the inter-State Transmission System) (Fourth Amendment) Regulations, 2025, GETCO comments are as under -

7. Amendment to Regulation 19.2 of the Principal Regulations:

**7.1. The Proviso to Regulation 19.2 of the Principal Regulation shall be substituted as under:
"Provided that such additional GNA quantum to be added in each of the next three financial years shall be applicable from a specified date(s) of the respective financial year subject to a maximum four dates for a year "**

As per Clause 17.(i) of Central Electricity Regulatory Commission (Connectivity and General Network Access to the inter-State Transmission System) Regulations, 2022, STU on behalf of intra-state entities submit the requirement of additional GNA every year. There are multiple intra-state entities in the State and each entity may have different start date of GNA as per their drawal requirement. Recently, for the F.Y 2025-26, on behalf of GUVNL, Gujarat STU applied for additional GNA with two different start dates. **It is suggested not to restrict the number of start date.**
