ORDER

This petition was heard on 21.2.2003. We were in the process of finalising the tariff order. In order to seek certain clarifications on financial issues in respect of assets covered by the present petition, the matter was discussed by the staff of the Commission with the officials of the petitioner company on 26.6.2003. After the discussions, the petitioner has submitted a letter dated 2.7.2003 wherein, it has been stated that the Central Government had notified the transmission tariff for Reactor at Gazuwaka and ICT at Khammam as a part of additional capitalisation of Ramagundam Transmission Line vide notification dated 14.5.1999 and the tariff for these assets has been claimed in the present petition. It is further stated that FERV claimed on unserviced outstanding IBRD loan utilised for Reactor at Gazuwaka and ICT at Khammam was not considered while filing the petition. In the said letter dated 2.7.2003, the petitioner has furnished

FERV for these assets calculated based on exchange rate difference from 31.1.1997 to 31.3.2001 in case of Reactor at Gazuwaka and from 31.12.1996 to 31.3.2001 in case of ICT at Khammam for the loans outstanding as on 31.3.2001. As a result of the information now furnished, the petitioner has revised the additional FERV capitalised by (+) Rs.1,45,20,480/- and has requested that this additional capitalised FERV may be considered for approval of tariff.

- 2. The petitioner cannot be allowed benefit of additional capitalised FERV as prayed for in the letter dated 2.7.2003, as the respondents have no notice of the additional claim put forth by the petitioner. We consider it appropriate that a formal application praying for amendment of the petition may be filed on behalf of the petitioner in accordance with the proper procedure, if it claims the benefit of additional FERV as stated in the said letter dated 2.7.2003. Accordingly, we grant liberty to the petitioner to file an appropriate application for amendment latest by 14.8.2003, with advance copy to the respondents who may file their replies by 31.8.2003 with a copy to the petitioner. The petitioner may file its rejoinder, if so advised, by 10.9.2003. In case no application for amendment is filed in accordance with liberty given, no further opportunity for the purpose shall be granted.
