Record of Proceedings

During the hearing, the learned counsel for the Petitioner, BRBCL submitted that the Respondent, ECR has filed Petition No. 333/MP/2018 regarding the validity of the COD of Units I & II of the generating station as declared by BRBCL (respondent therein). She further submitted that though preliminary objections have been filed in the said Petition, it may be permitted to file its reply on merits. She however prayed that the present tariff petition may be heard, pending disposal of Petition No. 333/MP/2018.

2. In response, the learned counsels for the Respondents, ECR and BSPHCL prayed that Petition No. 333/MP/2018 may be heard along with the present petition.

3. The Commission directed BRBCL to file, on affidavit, the following additional information in the present Petition, on or before **10.4.2019**:

i) Copy of Investment approval (original and revised) with schedule of commissioning, breakup of project cost and reason of increase in hard cost in the revised approval compared to the original approval along with the variation in scope of work, if any.

ii) Original investment approval cost along with reasons of increase in each package with respect to original investment approval.

iii) PERT/CPM chart indicating the critical activities/milestones which were affected due to each reason of delay with relevant supporting document. Reconciliation of the total delay period corresponding to each activity/milestones with individual delays corresponding to each reason of delay as per the format attached at **Annexure-1**. Any other relevant information for proving that time-overrun and consequent cost overrun, if any, was not attributable to to the Petitioner.

iv) Clarification as regards the sample taken for 'as received' GCV of coal is from wagon top at the unloading point or from anywhere else in the plant.

v) Details of HFO and LDO separately as per Form-15 A.

4. The Respondents (ECR & BSPHCL) shall file their replies on or before **24.4.2019** with copy to BRBCL, who shall file its rejoinder, if any, by **1.5.2019 in Petition No. 23/GT/2017**.


