### **ORDER**

The instant petition has been filed by Power Grid Corporation of India Limited (hereinafter referred to as “the Petitioner”), a deemed transmission licensee, for revision of transmission tariff of the 2001-04, 2004-09 and 2009-14 tariff periods; for truing-up of transmission tariff for the 2014-19 tariff period under the Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2014 (hereinafter referred to as “the 2014 Tariff Regulations”); and for determination of tariff for the 2019-24 tariff period under the Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2019 (hereinafter referred to as “the 2019 Tariff Regulations”) in respect of the following assets under “Transmission System associated with RAPP-B Project” in the Northern Region (hereinafter referred to as “the transmission project”):

**Asset-a:** 220 kV D/C RAPP-B-Chittorgarh Transmission Line;



**Asset-b:**220kV S/C RAPP-B-Udaipur Transmission Line alongwith associated bays at Udaipur end and LILO of 220kV D/C RAPP-KOTA Line at RAPP-B including PLCC System; and

**Asset-c:** 220kV S/C RAPP-B-Anta Transmission Line with associated Bays at Anta end.

2. The Petitioner has made the following prayers in this petition:

*“1.Approve the revised Transmission Tariff for 2001-04 block, 2004-09 block and transmission tariff for 2009-14 block for the assets covered under this petition, as per para 8 above.*

*2.Approve the trued up Transmission Tariff for 2014-19 block and transmission tariff for 2019-24 block for the assets covered under this petition, as per para 9 and 10 above.*

*3.Allow the Petitioner to recover the shortfall or refund the excess Annual Fixed Charges, on account of Return on Equity due to change in applicable Minimum Alternate/Corporate Income Tax rate as per the Income Tax Act, 1961 (as amended from time to time) of the respective financial year directly without making any application before the Commission as provided in Tariff regulations 2014 and tariff regulation'19 as per para 9.0 & 10 above for respective block.*

*Further it is submitted that deferred tax liability before 01.04.2009 shall be recoverable from the beneficiaries or long term customers /DIC as the case may be, as and when the same is materialized as per regulation 49 of 2014 and regulation 67 of 2019 tariff regulation. The Petitioner may be allow to recover the deferred tax liability materialized directly without making any application before the commission as provided in the regulation.*

*4.Approve the reimbursement of expenditure by the beneficiaries towards petition filing fee, and expenditure on publishing of notices in newspapers in terms of Regulation 70 (1) Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2019, and other expenditure ( if any) in relation to the filing of petition.*

*5.Allow the Petitioner to bill and recover Licensee fee and RLDC fees and charges, separately from the respondents in terms of Regulation 70 (3) and (4) Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2019.*

*6.Allow the Petitioner to file a separate petition before Hon'ble Commission for claiming the overall security expenses and consequential IOWC on that security expenses as mentioned at para 10.5 above.*

*7.Allow the Petitioner to claim the capital spares at the end of tariff block as per actual.*

*8.Allow the Petitioner to bill and recover GST on Transmission Charges separately*



*from the respondents, if GST on transmission is withdrawn from negative list at any time in future. Further, any taxes including GST and duties including cess etc. imposed by any statutory/Govt./municipal authorities shall be allowed to be recovered from the beneficiaries.*

*and pass such other relief as Hon'ble Commission deems fit and appropriate under the circumstances of the case and in the interest of justice”*

### **Background**

3. The brief facts of the case are as under:

a. The Investment Approval (IA) for the transmission project was accorded by the Central Government vide its letter dated 6.9.1995 at an estimated cost of ₹9780 lakh, including Interest During Construction (IDC) of ₹698 lakh. Subsequently, the cost of the transmission project was revised to ₹11608 lakh, including IDC of ₹2800 lakh and approval for the same was accorded by the Board of Directors of the Petitioner in its meeting held on 9.3.2000.

b. The transmission tariff for the period from 1.4.2001 to 31.3.2004 for the transmission project was determined vide order dated 18.5.2004 in Petition No. 50/2002. Further, the tariff for the 2001-04 period was revised on account of FERV adjustments vide order dated 8.2.2008 in Petition No.50/2002. The transmission tariff for the period from 1.4.2004 to 31.3.2009 was determined vide order dated 13.1.2006 in Petition No. 77/ 2004. Further, the tariff for the 2004-09 period was revised on account of FERV adjustments vide order dated 19.5.2008 in Petition No. 77/2004. The transmission tariff for combined elements of the assets was determined for the period from 1.4.2009 to 31.3.2014 vide order dated 19.1.2011 in Petition No.172/2010.

c. The tariff for the 2009-14 period was trued-up and tariff for the period from 1.4.2014 to 31.3.2019 was determined vide order dated 8.12.2015 in Petition No.359/TT/2014.

d. The dates of commercial operation of the assets covered in the instant petition are as under:

f. The Petitioner has sought revision of transmission tariff approved by the Commission for the 2001-04 and 2004-09 tariff periods on account of change in Interest on Loan (IoL) and Interest on Working Capital (IWC), w.e.f. 1.4.2007 to the extent of revision in IoL and in Maintenance Spares in terms of the judgements of the Appellate Tribunal for Electricity (APTEL) dated 22.1.2007 and 13.6.2007 in Appeal Nos. 81/2005 and 139/2006 respectively. The Petitioner has also sought consequential revision of tariff allowed for the 2009-14 tariff period, truing-up of tariff of the 2014-19 tariff period and determination of tariff for the 2019-24 tariff period for the transmission project.

g. APTEL vide judgements dated 22.1.2007 in Appeal No.81/2005 and other related Appeals and judgement dated 13.6.2007 in Appeal No. 139/2007 pertaining to generating stations of NTPC decided mainly the following issues:-

- (a) Computation of interest on loan
- (b) Consequences of refinancing of loan
- (c) Depreciation as deemed repayment
- (d) Admissibility of depreciation up to 90% of the value of the assets
- (e) Consideration of maintenance of spares for working capital
- (f) Depreciation of assets.

h. The Commission and certain interested parties preferred appeals against the APTEL's judgments before the Hon'ble Supreme Court in 2007. The appeals were admitted and initially stay was granted by the Hon'ble Supreme Court.



Subsequently, on an assurance by NTPC that the issues under appeal would not be pressed for implementation during the pendency of the appeals, the stay was vacated by the Hon'ble Supreme Court.

i. The Petitioners ought re-determination of tariff of the transmission assets for the 2001-04 and 2004-09 tariff periods vide Petition No. 121/2007. The Petitioner referred to APTEL's judgments dated 22.1.2007 in Appeal No. 81/2005 and 13.6.2007 in Appeal No. 139/2007 for re-determination of tariff. The Commission vide order dated 18.1.2019 in Petition No. 121/2007, after taking into consideration the pendency of Appeals before the Hon'ble Supreme Court adjourned the said petition *sine die* and directed that the same be revived after the disposal of Civil Appeals by the Hon'ble Supreme Court and also directed the Petitioner to separately submit its claim in the light of the APTEL's judgments dated 22.1.2007 and 13.6.2007 alongwith the truing-up Petitions to be filed for the period 2014-19 in respect of concerned transmission assets

j. The Hon'ble Supreme Court, vide its judgment and final order dated 10.4.2018, dismissed the said Civil Appeal No. 5843/2007 and connected 30 Civil Appeals.

k. Consequent to the Hon'ble Supreme Court's judgment dated 10.4.2018, Petition No. 121/2007 was listed for hearing before the Commission on 8.1.2019. The Commission, vide order dated 18.1.2019 in Petition No. 121/2007, directed the Petitioner to submit its claim separately for the assets at the time of filing of truing-up of the petitions for the 2014-19 tariff period in respect of the concerned transmission assets. Accordingly, the Petitioner has filed the instant petition.

l. In view of the APTEL's judgments dated 22.1.2007 in Appeal No. 81/2005 and 13.6.2007 in Appeal No. 139/2007 and the judgement of Hon'ble Supreme Court dated 10.4.2018, the tariff is being revised. Although tariff period wise tariff is being re-worked based on the Tariff Regulations applicable for the respective tariff periods, suitable assumptions at certain places, if required, are made as indicated.



m. Asset-a was put in commercial operation on 1.11.1998, Asset-b on 1.1.2000 and Asset-c on 1.8.2000. The tariff from 1.7.2000 was worked out based on capital cost of ₹4211.05 lakh, ₹4624.50 lakh and ₹2181.05 lakh on 31.3.2001 for Assets-a, b and c, respectively. Accordingly, considering the admitted capital cost, the tariff is being revised for the 2001-04, 2004-09, 2009-14 tariff periods in terms of the APTEL's judgement dated 22.1.2007 in Appeal No. 81/2005 and 13.6.2007 in Appeal No. 139/2007.

4. The Respondents are distribution licensees, transmission utilities and power departments, who are procuring transmission services from the Petitioner and are mainly beneficiaries of the Northern Region.

5. The Petitioner has served the petition on the Respondents and notice regarding filing of this petition has been published in newspapers in accordance with Section 64 of the Electricity Act, 2003. No comments or suggestions have been received from the general public in response to the aforesaid notices published in the newspapers. General Notice dated 14.1.2020 directing the beneficiaries/Respondents to file reply in the matter was also posted on the Commission's website. Respondent No.9, i.e. UPPCL has filed its reply vide affidavit dated 27.1.2020 and has raised issues like revision of tariff, computation of effective tax rate for the 2014-19 period and computation of grossed up RoE for the 2019-24 period. In response, the Petitioner has filed its rejoinder vide affidavit dated 21.8.2020.

6. This order is issued after considering the submissions made by the Petitioner vide affidavit dated 27.9.2019; reply of the Petitioner vide affidavit dated 20.7.2020 in response to technical validation letter; the reply of UPPCL dated 27.1.2020; and the Petitioner's rejoinder vide affidavit dated 21.8.2020 to the reply of UPPCL.

7. The hearing in this matter was held on 24.8.2020 through video conferencing.





8. Having heard the representatives of the Petitioner and perused the material on record, we proceed to dispose of the petition.

**REVISION OF TRANSMISSION CHARGES ALLOWED FOR THE 2001-04, 2004-09 AND 2009-14 TARIFF PERIOD**

9. UPPCL has submitted that revision in tariff for the 2001-04, 2004-9 and 2009-14 tariff periods has been effected on ground of the APTEL's judgment dated 22.1.2007 and 13.6.2007 in Appeal No. 81/2005 and 139/2006 respectively. UPPCL has contended that as both these judgements have not been attached along with the instant petition, UPPCL is unable to comment on the applicability and on the procedure as outlined in Enclosure 1 "Methodology for computation of Interest on Loan and Maintenance Spares for 2001-04 and 2004-09 Block" of the Petition.

10. In response, the Petitioner has submitted that it has enclosed the copy of APTEL's judgment dated 22.1.2007 in Appeal Nos. 81 of 2005, and judgements dated 13.6.2007 in Appeal Nos. 139 of 2006 and Others along with its rejoinder.

11. We have considered the contention of the Petitioner and UPPCL. As pointed out by UPPCL, the Petitioner should have submitted the judgements of APTEL along with the Petition. It is observed that the judgments of APTEL in the subject appeals are available in the public domain. Moreover, mere non-submission of the APTEL's judgement cannot be a cause for not entertaining the instant petition. Therefore, contention of UPPCL is rejected. However, the Petitioner is directed to submit all the related information along with the petition in future. The tariff for the 2001-04 and the 2004-09 tariff period is revised in the instant order based on the observations of APTEL and Hon'ble Supreme Court's judgement.



12. The Petitioner has sought revision of the computation of IoL, maintenance spares for working capital and depreciation allowed for the 2004-09 period based on the judgements of APTEL dated 22.1.2007 in Appeal No.81/2005 and 13.6.2007 in Appeal No.139/2006. APTEL, while dealing with the issue of computation of IoL, in its judgment dated 22.1.2007 in Appeal No.81/2005, held that for the period from 1.4.1998 to 31.3.2001 and from 1.4.2000 to 31.3.2001, IoL shall be computed only on normative loan repayment as per its judgement dated 14.11.2006 in Appeal No. 96 of 2005 and IA No. 117 of 2006 in Appeal No.94 and set aside the Commission's methodology of computation of loan on the basis of actual repayment or normative repayment whichever is higher. In view of the above, the interest allowed for the 2004-09 period is being revised on the basis of the normative debt repayment methodology. Relevant portion of the judgement dated 14.11.2006 in Appeal No. 96 of 2005 and IA No. 117 of 2006 in Appeal No. 94 is as under:

*"12. We have heard the arguments of the Senior Counsel(s) of appellant and respondents. We notice that the appellant has not challenged the formula for computing the annual repayment amount as provided in para-22 of the impugned order and has only challenged the provisions at para 23 (in specifying that the amount of annual repayment for calculation of interest on loan is chosen higher of the normative debt and actual debt.*

*13. As mentioned earlier the servicing of the capital (equity or debt) is financed by the recovery of interest on debt capital and through earning of return on equity capital. The actual loan repayment has been normalized to 50% of the total capital by the formula in para 22 of the impugned order given in para 11 above. Once it has been decided and agreed that the financing plan would be based on normative debt-equity ratio of 50:50 and not the actual debt-equity ratio, the same normative basis should be adopted for recovery of cost of servicing the capital.*

*14. In the instant case since the normative debt-equity ratio of 50:50 has been adopted in the financing plan, the loan repayment should be computed based on normative debt. This is to ensure that whatever normative debt has been considered, tariff should ensure the recovery of the same normative debt and interest thereon."*

*"18. In its Tariff Regulation of 2004 the Central Commission perhaps recognizing the aforesaid anomaly has dispensed with the practice of adopting higher of actual or normative repayment and has corrected the method of determination of quantum of debt repayment only on the basis of the normative debt with effect from 01.04.2004*

*19. In view of the above, the Central Commission is required to adopt normative debt repayment methodology for working out the interest on loan liability for the period 01.04.1998 to 31.03.2001."*



13. APTEL vide its judgement dated 13.6.2007 in Appeal No.139 of 2006 and ors. held that additional capital expenditure(ACE) after the date of commercial operation should also be considered for computation of maintenance spares. The relevant portion of the judgement dated 13.6.2017 is as under:-

***“Analysis and Decision***

*We are not inclined to agree with the contention of the respondents that escalation of 6% will take care of the additional capitalization. Escalation is meant to factor inflation and is allowed as per CERC Regulations whether or not additional capitalization takes place. Question before us is that: can the historical cost be frozen with the Commissioning of the station. It is quite normal and prudent to ensure earliest operation of the plant without necessarily 100% completion of plants and works, of course not at the cost of safety of the plant. Adding some of the plants and works after the commercial operation will reduce interest during construction. If technically it is possible to delay some of the plants or works, it is only prudent to do so. For example it is common to build redundancies in the plant at a little later stage. CERC’s own regulations rightly recognized additional capitalization. It is pertinent to set out excerpts pertaining to additional capitalization from CERC (Terms & Conditions of Tariff) Regulation, 2004 Clause 18 as below:-*

*“Additional capitalization (1) The following capital expenditure within the original scope of work actually incurred after the date of commercial operation and up to the cutoff date may be admitted by the Commission, subject to prudence check:*

- (i) Deferred liabilities*
- (ii) Works deferred for execution*
- (iii) Procurement of initial capital spares in the original scope of work, subject to ceiling specified in regulation 17.*
- (iv) Liabilities to meet award of arbitration or for compliance of the order or decree of a court; and*
- (v) On account of change in law.*

*Provided that original scope of work along with estimates of expenditure shall be submitted along with the application for provisional tariff.*

*Provided further that a list of the deferred liabilities and works deferred for execution shall be submitted along with the application for final tariff after the date of commercial operation of the generating station.”*

*It is clear from the abovementioned Clause 18 of the CERC Regulations that additional capitalization after the date of commercial operation is recognized as part of the capital expenditure. Historical cost does not literally mean that the cost on the date of the commercial operation. The term historical cost is used so as to distinguish it from ‘book value’ or ‘the replacement cost’. The cost of maintenance spares limited to 1% of the historical cost corresponds to the plant and equipment and installations which are required to be maintained. If the cost of additional equipment is not included in the historical cost, how spares for the additional equipment be procured for maintenance of the additional equipment. In this view of the matter, the CERC needs to examine afresh in the light of the aforesaid observations.”*



14. In view of the above, the maintenance spares to be considered for computation of working capital for the 2004-09 period are also required to be revised taking into consideration the ACE after the date of commercial operation.

15. APTEL in its judgement dated 13.6.2007 in Appeal No.139 of 2006 observed that depreciation is an expense and it cannot be deployed for deemed repayment of loan and accordingly directed the Commission to compute the outstanding loan afresh. The relevant portion of the judgement is as under:-

***“Analysis and Decision***

*In the orders of this Tribunal dated November 14, 2006 and January 24, 2007 it has been laid down that the computation of outstanding loan will be on normative basis only (instead of normative or actual whichever is higher). In view of this there is no question of any adjustment of the depreciation amount as deemed repayment of loan.*

*It is to be understood that the depreciation is an expense and not an item allowed for repayment of loan. If a corporation does not borrow, it would not mean that the corporation will not be allowed any depreciation. Depreciation is an expense it represents a decline in the value of asset because of use, wear or obsolescence. The Accounting Principles Board of USA defines depreciation as under:-*

*“The cost of a productive facility is one of the costs of the service it renders during its useful economic life. Generally accepted accounting principles require that this cost be spread over the expected useful life of the facility in such a way as to allocate it as equitably as possible to the periods during which services are obtained from the use of the facility. This procedure is known as depreciation accounting, a system of accounting which aims to distribute the cost or other basic value of tangible capital assets, less salvage (if any), over the estimated useful life of the unit (which may be a group of assets) in a systematic and rational manner. It is a process of allocation, not of valuation”*

*It is well established that the depreciation is an expense and therefore, it cannot be deployed for deemed repayment of loan. In this view of the matter the CERC shall need to make a fresh computation of outstanding loan in the light of the aforesaid observations.”*

16. In view of the above directions of APTEL, the outstanding loan allowed for the instant assets for the 2004-09 tariff period is revised in the instant order.

17. The revision of tariff allowed for the 2001-04 and 2004-09 tariff periods necessitates the revision of tariff allowed for the 2009-14 period, which is also being



done in the instant order. The implementation of the directions of APTEL in case of the Petitioner was kept pending in view of the Civil Appeals filed before the Hon'ble Supreme Court. Hence, taking into consideration the facts of the case and keeping in view the interest of the consumers, we are of the view that the beneficiaries should not be burdened with the carrying cost for the difference in the tariff allowed vide earlier orders and that allowed in the instant order for the 2001-04, 2004-09 and 2009-14 tariff periods. Therefore, the Petitioner will neither claim nor pay any carrying cost from/to the beneficiaries for the difference in the tariff allowed vide earlier orders and tariff allowed in the instant order. Further, the said difference in tariff shall be recovered from the beneficiaries over a period of six months from the date of issue of this order.

**2001-04 Period**

18. The Commission vide order dated 18.5.2004 in Petition No.50/2002 approved transmission charges for the instant assets for 2001-04 period and further vide order dated 8.2.2008 in Petition No. 50/2002 has revised the transmission charges for the Asset-b and Asset-c. The tariff considered for 2001-04 period is as under:

### **Capital Cost as on 1.4.2014**

34. The capital cost of the Combined Asset has been calculated in accordance with Regulations 9(3) of the 2014 Tariff Regulations. The Commission vide order dated 8.12.2015 in Petition No.359/TT/2014 had approved the transmission tariff for the 2014-19 period based on admitted capital cost of ₹10988.93 lakh as on 1.4.2014 for the Combined Asset.

35. The Petitioner has not claimed any ACE during the 2014-19 tariff period. Accordingly, the capital cost of ₹10988.93 lakh has been considered for the purpose of truing-up of the tariff of the 2014-19 tariff period.

### **Debt-Equity Ratio**

36. Regulation 19(3) of the 2014 Tariff Regulations provides as under:

*“(3) In case of the generating station and the transmission system including communication system declared under commercial operation prior to 1.4.2014, debt-equity ratio allowed by the Commission for determination of tariff for the period ending 31.3.2014 shall be considered.”*

37. The Petitioner has considered debt-equity ratio as 80.99:19.01, which was approved vide order dated 19.1.2011 in Petition No. 172/2010 and the same was allowed for determination of tariff for the period ending 31.3.2019 in order dated 8.12.2015 in Petition No. 359/TT/2014. ### **Interest on Loan (IoL)**

38. The Petitioner has not claimed any IoL for the tariff period 2014-19 as the entire loan has already been repaid during 2010-11. Accordingly, IoL has been considered as NIL for the purpose of tariff.

### **Return on Equity (RoE)**

39. UPPCL has submitted that it is not clear whether the tax on other income stream has been excluded. UPPCL has further submitted that the Petitioner has considered 'Total Tax and Interest paid', but from submissions of the Petitioner, the amount of interest included is not clear. It is also not clear whether it is in nature of penalty for delay in deposit of tax. In response, the Petitioner has submitted that so far it has been granted trued-up tariff for the 2014-19 period by the Commission vide order dated 18.4.2020 in Petition No. 247/TT/2019, vide order dated 27.4.2020 in Petition No. 274/TT/2019, vide order dated 23.4.2020 in Petition No. 245/TT/2019 and vide order dated 16.4.2020 in Petition No. 307/TT/2019 for transmission assets under the respective petitions, where following effective tax rate based for the 2014-19 tariff period) on notified MAT rates are considered for the purpose of grossing-up of rate of Return on Equity (RoE) where tariff for each year of the tariff period 2014-19 is being determined by the Commission considering the effective tax percentage to arrive at grossed up RoE:

40. We have considered the submissions of the Petitioner and UPPCL. The tariff for each year of the tariff period 2014-19 is determined considering the effective tax percentage to arrive at grossed up RoE. The Commission vide order dated 27.4.2020 in Petition No.274/TT/2019 has arrived at the effective tax rate based on the notified MAT rates for the Petitioner. The relevant portion of the order dated 27.4.2020 is as under:

*“26. We are conscious that the entities covered under MAT regime are paying Income Tax as per MAT rate notified for respective financial year under IT Act, 1961, which is levied on the book profit of the entity computed as per the Section 115JB of the IT Act, 1961. The Section 115JB(2) defines book profit as net profit in the statement of Profit & Loss prepared in accordance with Schedule-III of the Companies Act, 2013, subject to some additions and deductions as mentioned in the IT Act, 1961. Since the Petitioner has been paying income tax on income computed under Section 115JB of the IT Act, 1961 as per the MAT rates of the respective financial year, the notified MAT rate for respective financial year shall be considered as effective tax rate for the purpose of grossing up of RoE for truing up of the tariff of the 2014-19 tariff period in terms of the provisions of the 2014 Tariff Regulations. Interest imposed on any additional income tax demand as per the Assessment Order of the Income Tax authorities shall be considered on actual payment. However, penalty (for default on the part of the Assessee) if any imposed shall not be taken into account for the purpose of grossing up of rate of return on equity. Any under-recovery or over-recovery of grossed up rate on return on equity after truing up, shall be recovered or refunded to beneficiaries or the long-term transmission customers/ DICs as the case may be on year to year basis.*

### **Capital Cost**

56. Regulation 19 of the 2019 Tariff Regulations provides as under:

**“19. Capital Cost:**(1) *The Capital cost of the generating station or the transmission system, as the case may be, as determined by the Commission after prudence check in accordance with these regulations shall form the basis for determination of tariff for existing and new projects.*

(2) *The Capital Cost of a new project shall include the following:*

(a) *The expenditure incurred or projected to be incurred up to the date of commercial operation of the project;*

(b) *Interest during construction and financing charges, on the loans (i) being equal to 70% of the funds deployed, in the event of the actual equity in excess of 30% of the funds deployed, by treating the excess equity as normative loan, or (ii) being equal to the actual amount of loan in the event of the actual equity less than 30% of the funds deployed;*

(c) *Any gain or loss on account of foreign exchange risk variation pertaining to the loan amount availed during the construction period;*

(d) *Interest during construction and incidental expenditure during construction as computed in accordance with these regulations;*

(e) *Capitalised initial spares subject to the ceiling rates in accordance with these regulations;*



- (f) Expenditure on account of additional capitalization and de-capitalisation determined in accordance with these regulations;
- (g) Adjustment of revenue due to sale of infirm power in excess of fuel cost prior to the date of commercial operation as specified under Regulation 7 of these regulations;
- (h) Adjustment of revenue earned by the transmission licensee by using the assets before the date of commercial operation;
- (i) Capital expenditure on account of ash disposal and utilization including handling and transportation facility;
- (j) Capital expenditure incurred towards railway infrastructure and its augmentation for transportation of coal upto the receiving end of the generating station but does not include the transportation cost and any other appurtenant cost paid to the railway;
- (k) Capital expenditure on account of biomass handling equipment and facilities, for co-firing;
- (l) Capital expenditure on account of emission control system necessary to meet the revised emission standards and sewage treatment plant;
- (m) Expenditure on account of fulfilment of any conditions for obtaining environment clearance for the project;
- (n) Expenditure on account of change in law and force majeure events; and
- (o) Capital cost incurred or projected to be incurred by a thermal generating station, on account of implementation of the norms under Perform, Achieve and Trade (PAT) scheme of Government of India shall be considered by the Commission subject to sharing of benefits accrued under the PAT scheme with the beneficiaries.

(3) The Capital cost of an existing project shall include the following:

- (a) Capital cost admitted by the Commission prior to 1.4.2019 duly trued up by excluding liability, if any, as on 1.4.2019;
- (b) Additional capitalization and de-capitalization for the respective year of tariff as determined in accordance with these regulations;
- (c) Capital expenditure on account of ash disposal and utilization including handling and transportation facility;
- (d) Capital expenditure on account of ash disposal and utilization including handling and transportation facility;
- (e) Capital expenditure incurred towards railway infrastructure and its augmentation for transportation of coal up to the receiving end of generating station but does not include the transportation cost and any other appurtenant cost paid to the railway; and
- (f) Capital cost incurred or projected to be incurred by a thermal generating station, on account of implementation of the norms under Perform, Achieve and Trade (PAT) scheme of Government of India shall be considered by the Commission subject to sharing of benefits accrued under the PAT scheme with the beneficiaries.”

(4) The capital cost in case of existing or new hydro generating station shall also include:

- (a) cost of approved rehabilitation and resettlement (R&R) plan of the project in conformity with National R&R Policy and R&R package as approved; and
- (b) cost of the developer's 10% contribution towards Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY) and Deendayal Upadhyaya Gram Jyoti Yojana (DDUGJY) project in the affected area.

(5) The following shall be excluded from the capital cost of the existing and new projects:

- (a) The assets forming part of the project, but not in use, as declared in the tariff petition;



*(b) De-capitalised Assets after the date of commercial operation on account of replacement or removal on account of obsolescence or shifting from one project to another project:*

*Provided that in case replacement of transmission asset is recommended by Regional Power Committee, such asset shall be decapitalised only after its redeployment;*

*Provided further that unless shifting of an asset from one project to another is of permanent nature, there shall be no de-capitalization of the concerned assets.*

*(c) In case of hydro generating stations, any expenditure incurred or committed to be incurred by a project developer for getting the project site allotted by the State Government by following a transparent process;*

*(d) Proportionate cost of land of the existing project which is being used for generating power from generating station based on renewable energy; and*

*(e) Any grant received from the Central or State Government or any statutory body or authority for the execution of the project which does not carry any liability of repayment.”*

57. The capital cost of ₹10988.93 lakh has been considered for the Combined Asset as on 31.3.2019. The Petitioner has not claimed any ACE during the 2019-24 tariff period. Therefore, the capital cost of ₹10988.93 lakh as on 31.3.2019 has been considered for the purpose of determination of transmission tariff for the 2019-24 tariff period in accordance with Regulation 19 of the 2019 Tariff Regulations.

### **Debt-Equity Ratio**

58. Regulation 18 of the 2019 Tariff Regulations provides as under:-

**“18. Debt-Equity Ratio:** (1) For new projects, the debt: equity ratio of 70:30 as on date of commercial operation shall be considered. If the equity actually deployed is more than 30% of the capital cost, equity in excess of 30% shall be treated as normative loan:

*Provided that:*

- i. where equity actually deployed is less than 30% of the capital cost, actual equity shall be considered for determination of tariff:*
- ii. the equity invested in foreign currency shall be designated in Indian rupees on the date of each investment:*
- iii. any grant obtained for the execution of the project shall not be considered as a part of capital structure for the purpose of debt: equity ratio.*

**Explanation-***The premium, if any, raised by the generating company or the transmission licensee, as the case may be, while issuing share capital and investment of internal resources created out of its free reserve, for the funding*



*of the project, shall be reckoned as paid up capital for the purpose of computing return on equity, only if such premium amount and internal resources are actually utilised for meeting the capital expenditure of the generating station or the transmission system.*

*(2) The generating company or the transmission licensee, as the case may be, shall submit the resolution of the Board of the company or approval of the competent authority in other cases regarding infusion of funds from internal resources in support of the utilization made or proposed to be made to meet the capital expenditure of the generating station or the transmission system including communication system, as the case may be.*

*(3) In case of the generating station and the transmission system including communication system declared under commercial operation prior to 1.4.2019, debt: equity ratio allowed by the Commission for determination of tariff for the period ending 31.3.2019 shall be considered:*

*Provided that in case of a generating station or a transmission system including communication system which has completed its useful life as on or after 1.4.2019, if the equity actually deployed as on 1.4.2019 is more than 30% of the capital cost, equity in excess of 30% shall not be taken into account for tariff computation;*

*Provided further that in case of projects owned by Damodar Valley Corporation, the debt: equity ratio shall be governed as per sub-clause (ii) of clause (2) of Regulation 72 of these regulations.*

*(4) In case of the generating station and the transmission system including communication system declared under commercial operation prior to 1.4.2019, but where debt: equity ratio has not been determined by the Commission for determination of tariff for the period ending 31.3.2019, the Commission shall approve the debt: equity ratio in accordance with clause (1) of this Regulation.*

*(5) Any expenditure incurred or projected to be incurred on or after 1.4.2019 as may be admitted by the Commission as additional capital expenditure for determination of tariff, and renovation and modernisation expenditure for life extension shall be serviced in the manner specified in clause (1) of this Regulation.”*

59. The Petitioner has considered debt-equity ratio as 80.99:19.01, which was approved by the Commission vide order dated 19.1.2011 in Petition No. 172/2010 and the same was allowed for determination of tariff for the period ending 31.3.2019 in order dated 8.12.2015 in Petition No. 359/TT/2014. The admitted debt-equity ratio of 80.99:19.01 for the tariff period ending 31.3.2019 has been considered as opening debt-equity ratio as on 1.4.2019. The details of the debt-equity ratio considered for the purpose of the tariff for 2019-24 tariff period is as under:

### **Return on Equity (RoE)**

60. Regulations 30 and 31 of the 2019 Tariff Regulations specify as under:

**“30. Return on Equity:** (1) Return on equity shall be computed in rupee terms, on the equity base determined in accordance with Regulation 18 of these regulations.

(2) Return on equity shall be computed at the base rate of 15.50% for thermal generating station, transmission system including communication system and run-of river hydro generating station, and at the base rate of 16.50% for the storage type hydro generating stations including pumped storage hydro generating stations and run-of river generating station with pondage:

*Provided that return on equity in respect of additional capitalization after cut-off date beyond the original scope excluding additional capitalization due to Change in Law, shall be computed at the weighted average rate of interest on actual loan portfolio of the generating station or the transmission system;*

*Provided further that:*

*i. In case of a new project, the rate of return on equity shall be reduced by 1.00% for such period as may be decided by the Commission, if the generating station or transmission system is found to be declared under commercial operation without commissioning of any of the Restricted Governor Mode Operation (RGMO) or Free Governor Mode Operation (FGMO), data telemetry, communication system up to load dispatch centre or protection system based on the report submitted by the respective;*

*ii. in case of existing generating station, as and when any of the requirements under (i) above of this Regulation are found lacking based on the report submitted by the concerned RLDC, rate of return on equity shall be reduced by 1.00% for the period for which the deficiency continues;*

*iii. in case of a thermal generating station, with effect from 1.4.2020:*

*a) rate of return on equity shall be reduced by 0.25% in case of failure to achieve the ramp rate of 1% per minute;*

*b) an additional rate of return on equity of 0.25% shall be allowed for every incremental ramp rate of 1% per minute achieved over and above the ramp rate of 1% per minute, subject to ceiling of additional rate of return on equity of 1.00%:*

*Provided that the detailed guidelines in this regard shall be issued by National Load Dispatch Centre by 30.6.2019.”*

**“31. Tax on Return on Equity:**(1) The base rate of return on equity as allowed by the Commission under Regulation 30 of these regulations shall be grossed up with



*the effective tax rate of the respective financial year. For this purpose, the effective tax rate shall be considered on the basis of actual tax paid in respect of the financial year in line with the provisions of the relevant Finance Acts by the concerned generating company or the transmission licensee, as the case may be. The actual tax paid on income from other businesses including deferred tax liability (i.e. income from business other than business of generation or transmission, as the case may be) shall be excluded for the calculation of effective tax rate.*

*(2) Rate of return on equity shall be rounded off to three decimal places and shall be computed as per the formula given below:*

$$\text{Rate of pre-tax return on equity} = \text{Base rate} / (1-t)$$

*Where “t” is the effective tax rate in accordance with clause (1) of this Regulation and shall be calculated at the beginning of every financial year based on the estimated profit and tax to be paid estimated in line with the provisions of the relevant Finance Act applicable for that financial year to the company on pro-rata basis by excluding the income of non-generation or non-transmission business, as the case may be, and the corresponding tax thereon. In case of generating company or transmission licensee paying Minimum Alternate Tax (MAT), “t” shall be considered as MAT rate including surcharge and cess.*

**Illustration-**

*(i) In case of a generating company or a transmission licensee paying Minimum Alternate Tax (MAT) @ 21.55% including surcharge and cess:*

$$\text{Rate of return on equity} = 15.50 / (1 - 0.2155) = 19.758\%$$

*(ii) In case of a generating company or a transmission licensee paying normal corporate tax including surcharge and cess:*

- (a) Estimated Gross Income from generation or transmission business for FY 2019-20 is Rs 1,000 crore;*
- (b) Estimated Advance Tax for the year on above is Rs 240 crore;*
- (c) Effective Tax Rate for the year 2019-20 = Rs 240 Crore / Rs 1000 Crore = 24%;*
- (d) Rate of return on equity = 15.50 / (1 - 0.24) = 20.395%.*

*(3) The generating company or the transmission licensee, as the case may be, shall true up the grossed up rate of return on equity at the end of every financial year based on actual tax paid together with any additional tax demand including interest thereon, duly adjusted for any refund of tax including interest received from the income tax authorities pertaining to the tariff period 2019-24 on actual gross income of any financial year. However, penalty, if any, arising on account of delay in deposit or short deposit of tax amount shall not be claimed by the generating company or the transmission licensee. Any under-recovery or over-recovery of grossed up rate on return on equity after truing up, shall be recovered or refunded to beneficiaries or the long-term customers, as the case may be, on year to year basis.”*

61. UPPCL has submitted that the MAT Rate has been reduced from 18.5% to 15%, but the Petitioner has not considered this reduced MAT Rate for computation of



grossed up RoE. In response, the Petitioner has submitted that there is a change in MAT rate applicable for 2019-20 on account of Taxation Laws (Amendment) Ordinance, 2019 published in the Gazette dated 20.9.2019 and submitted the following:

a) The Petitioner is liable to pay income tax at MAT rate prescribed. Accordingly, the RoE has been calculated @18.782% after grossing up RoE with MAT rate of 17.472% (Base Rate 15% + surcharge 12% + cess 4%) based on the formula given in Regulation 31(2) of the 2019 Tariff Regulations for the 2019-24 period.

b) As per Regulation 31(3) of the 2019 Tariff Regulations, the grossed up rate of RoE at the end of every financial year shall be trued-up based on actual tax paid together with any additional tax demand including interest thereon duly adjusted for any refund of tax (including interest) received from the IT authorities pertaining to the 2019-24 tariff period on actual gross income of any financial year. However, penalty, if any, arising on account of delay in deposit or short deposit of tax amount shall not be claimed by the generating company or the transmission licensee.

c) Any under-recovery or over-recovery of grossed up rate on ROE after truing up shall be recovered or refunded to beneficiaries or the long-term customers, as the case may be, on year to year basis. Adjustment due to any additional tax demand including interest duly adjusted for any refund of tax including interest received from IT authorities shall be recoverable during the tariff period 2019-24 on year to year basis on receipt of Income Tax assessment order.

62. We have considered the submissions made by the Petitioner and UPPCL. Regulation 30 read with Regulation 31 of the 2019 Tariff Regulations provides for grossing up of ROE with the effective tax rate for the purpose of RoE. It further provides that in case the generating company or transmission licensee is paying Minimum Alternative Tax (MAT), the MAT rate including surcharge and cess will be considered for the grossing up of RoE. Accordingly, the MAT rate applicable during



2019-20 has been considered for the purpose of RoE, which shall be trued-up with actual tax rate in accordance with Regulation 31(3) of the 2019 Tariff Regulations. The RoE allowed for the Combined Asset as under:

### Interest on Loan (IoL)

63. The Petitioner has not claimed any IoL for the tariff period 2014-19 as the entire loan has already been repaid during 2010-11. Accordingly, IoL has been considered as NIL for the purpose of tariff.

### Depreciation

64. Regulation 33 of the 2019 Tariff Regulations provides as under:

**"33. Depreciation:**(1) *Depreciation shall be computed from the date of commercial operation of a generating station or unit thereof or a transmission system or element thereof including communication system. In case of the tariff of all the units of a generating station or all elements of a transmission system including communication system for which a single tariff needs to be determined, the depreciation shall be computed from the effective date of commercial operation of the generating station or the transmission system taking into consideration the depreciation of individual units:*

*Provided that effective date of commercial operation shall be worked out by considering the actual date of commercial operation and installed capacity of all the units of the generating station or capital cost of all elements of the transmission system, for which single tariff needs to be determined.*

(2) *The value base for the purpose of depreciation shall be the capital cost of the asset admitted by the Commission. In case of multiple units of a generating station or multiple elements of a transmission system, weighted average life for the generating station of the transmission system shall be applied. Depreciation shall be chargeable from the first year of commercial operation. In case of commercial operation of the asset for part of the year, depreciation shall be charged on pro rata basis.*



(3) *The salvage value of the asset shall be considered as 10% and depreciation shall be allowed up to maximum of 90% of the capital cost of the asset:*

*Provided that the salvage value for IT equipment and software shall be considered as NIL and 100% value of the assets shall be considered depreciable;*

*Provided further that in case of hydro generating stations, the salvage value shall be as provided in the agreement, if any, signed by the developers with the State Government for development of the generating station:*

*Provided also that the capital cost of the assets of the hydro generating station for the purpose of computation of depreciated value shall correspond to the percentage of sale of electricity under long-term power purchase agreement at regulated tariff:*

*Provided also that any depreciation disallowed on account of lower availability of the generating station or unit or transmission system as the case may be, shall not be allowed to be recovered at a later stage during the useful life or the extended life.*

(4) *Land other than the land held under lease and the land for reservoir in case of hydro generating station shall not be a depreciable asset and its cost shall be excluded from the capital cost while computing depreciable value of the asset.*

(5) *Depreciation shall be calculated annually based on Straight Line Method and at rates specified in Appendix-I to these regulations for the assets of the generating station and transmission system:*

*Provided that the remaining depreciable value as on 31st March of the year closing after a period of 12 years from the effective date of commercial operation of the station shall be spread over the balance useful life of the assets.*

(6) *In case of the existing projects, the balance depreciable value as on 1.4.2019 shall be worked out by deducting the cumulative depreciation as admitted by the Commission up to 31.3.2019 from the gross depreciable value of the assets.*

(7) *The generating company or the transmission licensee, as the case may be, shall submit the details of proposed capital expenditure five years before the completion of useful life of the project along with justification and proposed life extension. The Commission based on prudence check of such submissions shall approve the depreciation on capital expenditure.*

(8) *In case of de-capitalization of assets in respect of generating station or unit thereof or transmission system or element thereof, the cumulative depreciation shall be adjusted by taking into account the depreciation recovered in tariff by the decapitalized asset during its useful services.”*



65. The depreciation has been worked out considering the admitted capital cost of ₹10988.93 lakh as on 31.3.2019 and accumulated depreciation up to 31.3.2019. The detailed calculations for depreciation for the Combined Asset are as under:

66. Regulation 35(3)(a) and (4) of the 2019 Tariff Regulations specifies the norms for the O&M Expenses for the transmission system and the same is provided as under:

“(3) Transmission system: (a) The following normative operation and maintenance expenses shall be admissible for the transmission system:

*Provided further that:*

- i. the operation and maintenance expenses for new HVDC bi-pole schemes commissioned after 1.4.2019 for a particular year shall be allowed pro-rata on the basis of normative rate of operation and maintenance expenses of similar HVDC bi-pole scheme for the corresponding year of the tariff period;*
- ii. the O&M expenses norms for HVDC bi-pole line shall be considered as Double Circuit quad AC line;*
- iii. the O&M expenses of ±500 kV Mundra-Mohindergarh HVDC bipole scheme (2000 MW) shall be allowed as worked out by multiplying 0.80 of the normative O&M expenses for ±500 kV Talchar-Kolar HVDC bi-pole scheme (2000 MW);*
- iv. the O&M expenses of ±800 kV Champa-Kurukshetra HVDC bi-pole scheme (3000 MW) shall be on the basis of the normative O&M expenses for ±800 kV, Bishwanath-Agra HVDC bi-pole scheme;*
- v. the O&M expenses of ±800 kV, Alipurduar-Agra HVDC bi-pole scheme (3000*



MW) shall be allowed as worked out by multiplying 0.80 of the normative O&M expenses for  $\pm 800$  kV, Bishwanath-Agra HVDC bi-pole scheme; and

vi. the O&M expenses of Static Synchronous Compensator and Static Var Compensator shall be worked at 1.5% of original project cost as on commercial operation which shall be escalated at the rate of 3.51% to work out the O&M expenses during the tariff period. The O&M expenses of Static Synchronous Compensator and Static Var Compensator, if required, may be reviewed after three years.

(b) The total allowable operation and maintenance expenses for the transmission system shall be calculated by multiplying the number of sub-station bays, transformer capacity of the transformer (in MVA) and km of line length with the applicable norms for the operation and maintenance expenses per bay, per MVA and per km respectively.

(c) The Security Expenses and Capital Spares for transmission system shall be allowed separately after prudence check:

Provided that the transmission licensee shall submit the assessment of the security requirement and estimated security expenses, the details of year-wise actual capital spares consumed at the time of truing up with appropriate justification.

(4) Communication system: The operation and maintenance expenses for the communication system shall be worked out at 2.0% of the original project cost related to such communication system. The transmission licensee shall submit the actual operation and maintenance expenses for truing up.”

68. The Petitioner has claimed O&M Expenses separately for the PLCC under Regulation 35(4) of the 2019 Tariff Regulations @2% of its original project cost in the instant petition. The Petitioner has made similar claim in other petitions as well. Though PLCC is a communication system, it has been considered as part of the sub-station in the 2014 Tariff Regulations and the 2019 Tariff Regulations and the norms for sub-station have been specified accordingly. Accordingly, the Commission vide order dated 24.1.2021 in Petition No.126/TT/2020 has already concluded that no separate O&M Expenses can be allowed for PLCC under Regulation 35(4) of the 2019 Tariff Regulations even though PLCC is a communication system. Therefore, the Petitioner's claim for separate O&M Expenses for PLCC @2% is not allowed. The relevant portions of the order dated 24.1.2021 in Petition No.126/TT/2020 are extracted hereunder:

*"103. Thus, although PLCC equipment is a communication system, it has been considered as a part of sub-station, as it is used both for protection and communication. Therefore, we are of the considered view that rightly, it was not considered for separate O&M Expenses while framing norms of O&M for 2019-24 tariff period. While specifying norms for bays and transformers, O&M Expenses for PLCC have been included within norms for O&M Expenses for sub-station. Norms of O&M Expenses @2% of the capital cost in terms of Regulation 35(4) of the 2019 Tariff Regulations have been specified for communication system such as PMU, RMU, OPGW etc. and not for PLCC equipment."*

*"105. In our view, granting of O&M Expenses for PLCC equipment @2% of its capital cost under Regulation 35(4) of the 2014 Tariff Regulations under the communication system head would tantamount to granting O&M Expenses twice for PLCC equipment*



as PLCC equipment has already been considered as part of the sub-station. Therefore, the Petitioner's prayer for grant of O&M Expenses for the PLCC equipment @2% of its capital cost under Regulation 35(4) of the 2014 Tariff Regulations is rejected.

106. The principle adopted in this petition that PLCC is part of sub-station and accordingly no separate O&M Expenses is admissible for PLCC equipment in the 2019-24 tariff period under Regulation 35(4) of the 2019 Tariff Regulations shall be applicable in case of all petitions where similar claim is made by the Petitioner. As already mentioned, the Commission, however, on the basis of the claim made by the Petitioner has inadvertently allowed O&M Expenses for PLCC equipment @2% of its original project cost, which is applicable for other "communication system", for 2019-24 period in 31 petitions given in Annexure-3 of this order. Therefore, the decision in this order shall also be applicable to all the petitions given in Annexure-3. Therefore, PGCIL is directed to bring this decision to the notice of all the stakeholders in the 31 petitions given in Annexure-3 and also make revised claim of O&M Expenses for PLCC as part of the sub-station at the time of truing up of the tariff allowed for 2019-24 period in respective petitions. "

Therefore, the Petitioner's claim for separate O&M Expenses for PLCC @2% is not allowed.

69. O&M Expenses (after disallowance of PLCC) allowed for the Combined Asset is as under:

### Interest on Working Capital (“IWC”)

70. Regulations 34(1)(c), (3) and(4) and 3(7) of the 2019 Tariff Regulations provide as follows:

*“34. Interest on Working Capital*

*(1)...*

*(c) For Hydro Generating Station (including Pumped Storage Hydro Generating Station) and Transmission System:*

- i. Receivables equivalent to 45 days of fixed cost;*
- ii. Maintenance spares @ 15% of operation and maintenance expenses including security expenses; and*
- iii. Operation and maintenance expenses, including security expenses for one month”*

*“(3)Rate of interest on working capital shall be on normative basis and shall be considered as the bank rate as on 1.4.2019 or as on 1st April of the year during the tariff period 2019-24 in which the generating station or a unit thereof or the transmission system including communication system or element thereof, as the case may be, is declared under commercial operation, whichever is later:*

*Provided that in case of truing-up, the rate of interest on working capital shall be considered at bank rate as on 1st April of each of the financial year during the tariff period 2019-24.*

*(4) Interest on working capital shall be payable on normative basis notwithstanding that the generating company or the transmission licensee has not taken loan for working capital from any outside agency.”*

*“3.Definitions ...*

*(7) ‘Bank Rate’ means the one year marginal cost of lending rate (MCLR) of the State Bank of India issued from time to time plus 350 basis points;”*

71. The Petitioner has submitted that it has computed IWC for the 2019-24 tariff period considering the SBI Base Rate plus 350 basis points as on 1.4.2019. The Petitioner has considered the rate of IWC as 12.05%. IWC is worked out in accordance with Regulation 34 of the 2019 Tariff Regulations. The rate of IWC considered is 12.05% (SBI 1year MCLR applicable as on 1.4.2019 of 8.55% plus 350



basis points) for 2019-20 and 11.25% (SBI 1-year MCLR applicable as on 1.4.2020 of 7.75% plus 350 basis points) for 2020-24. The components of the working capital and interest allowed for the Combined Asset is as follows:

### **Filing Fee and Publication Expenses**

73. The Petitioner has sought reimbursement of fee paid by it for filing the petition and publication expenses, in terms of Regulation 70(1) of the 2019 Tariff Regulations. The Petitioner shall be entitled for reimbursement of the filing fees and publication expenses in connection with the present petition, directly from the beneficiaries on pro-rata basis in accordance with Regulation 70(1) of the 2019 Tariff Regulations.

### **Licence Fee & RLDC Fees and Charges**

74. The Petitioner has requested to allow it to bill and recover license fee and RLDC fees and charges, separately from the Respondents. The Petitioner shall be



entitled for reimbursement of licence fee in accordance with Regulation 70(4) of the 2019 Tariff Regulations for the 2019-24 tariff period. The Petitioner shall also be entitled for recovery of RLDC fee and charges in accordance with Regulations 70(3) of the 2019 Tariff Regulations for the 2019-24 tariff period.

### **Goods and Services Tax**

75. The Petitioner has sought to recover GST on transmission charges separately from the Respondents, if GST on transmission is withdrawn from negative list in future. We have considered the submission of the Petitioner. GST is not levied on transmission service at present and we are of the view that Petitioner's prayer is premature.

### **Security Expenses**

76. The Petitioner has submitted that security expenses for the instant assets are not claimed in the instant petition and it would file a separate petition for claiming the overall security expenses and the consequential IWC. The Petitioner has requested to consider the actual security expenses incurred during 2018-19 for claiming estimated security expenses for 2019-20 which shall be subject to true up at the end of the year based on the actuals. The Petitioner has submitted that similar petition for security expenses for 2020-21, 2021-22, 2022-23 and 2023-24 shall be filed on a yearly basis based on the actual expenses of previous year subject to true up at the end of the year on actual expenses. The Petitioner has submitted that the difference, if any, between the estimated security expenses and actual security expenses as per the audited accounts may be allowed to be recovered from the beneficiaries on a yearly basis.



77. We have considered the submissions of the Petitioner. We are of the view that the Petitioner should claim security expenses for all the transmission assets in one petition. It is observed that the Petitioner has already filed the Petition No. 260/MP/2020 claiming consolidated security expenses on projected basis for the 2019-24 tariff period based on actual security expenses incurred in 2018-19. Therefore, security expenses will be dealt with in Petition No. 260/MP/2020 in accordance with the applicable provisions of the 2019 Tariff Regulations.

### **Capital Spares**

78. The Petitioner has sought reimbursement of capital spares at the end of the tariff period. The Petitioner's claim, if any, shall be dealt with in accordance with the provisions of the 2019 Tariff Regulations.

### **Sharing of Transmission Charges**

79. Tariff for Transmission of Electricity (Annual Fixed Cost) shall be recovered on monthly basis in accordance with Regulation 43 of Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2014 and Regulation 57 of Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2019 and shall be shared by the beneficiaries and long term transmission customers in the Central Electricity Regulatory Commission (Sharing of Inter State Transmission Charges and Losses) Regulations, 2010 or the Central Electricity Regulatory Commission (Sharing of Inter State Transmission Charges and Losses) Regulations, 2020, as the case may be.

80. To summarise, revised Annual Fixed Charges (AFC) allowed for the Assets-a, b and c for the 2001-02 to 2003-04 period and 2004-09 tariff period and revised AFC for the Combined Asset for the 2009-14 tariff period and the trued-up AFC approved for the Combined Asset for the 2014-19 tariff period are as under:
