Preface

Central Electricity Regulatory Commission (CERC) is entrusted with wide range of responsibilities under Electricity Act, 2003. The Commission discharges its functions by issuing regulations and orders. The regulation making is a legislative function which the Commission performs by virtue of delegated legislation under the statute.

The Commission has over the period issued regulations on a number of issues detailed in Section 178 of the Act. The regulations provide the desired regulatory certainty for the investors as well as for the consumers. The Commission also binds itself by framing regulations and issues orders in pursuance of the overarching principles enunciated in these regulations.
