NOTICE UNDER CLAUSE (a) OF SUB-SECTION (5) OF SECTION 15 OF THE ELECTRICITY ACT, 2003

An application under Section 14 of the Electricity Act, 2003 (the Act) has been made by POWERGRID Ananthpuram Kurnool Transmission Limited, B-9, Qutab Institutional Area, Katwaria Sarai, New Delhi - 110016, for the grant of a separate transmission licence for the implementation of transmission system for Implementation of 3 nos. of 400kV line bays at Ananthpuram PS for integration of RE generation projects through "Regulated Tariff Mechanism" (RTM) mode (hereinafter referred to as the 'transmission scheme/project'). The scope of the project for which a transmission licence has been sought is as follows:

2.	1no. of 400 kV line bay at Ananthpuram PS for Connectivity to M/s ABC Cleantech Pvt. Ltd.	400kV line bays - 1 No.	31.3.2026

2. The Central Transmission Utility of India Limited vide its letter dated 19.4.2024 has recommended for the grant of a transmission licence to the applicant to establish the proposed transmission system.
3. Based on the material available on the record, the Commission vide order dated 11.7.2024 in Petition No. 172/TL/2024, has proposed to issue a transmission licence to the applicant for establishment of the transmission scheme as noted in para 1 above.
4. A copy of the application, along with its annexures and enclosures, made by the applicant for the grant of an inter-State transmission licence to POWERGRID Ananthpuram Kurnool Transmission Limited before the Commission can be accessed at the website <https://www.powergrid.in/en/powergrid-ananthpuram-kurnool-transmission-limited> or inspected by any person in the Commission's office by following the laid down procedure.
5. Notice is hereby given in pursuance of clause (a) of sub-section (5) of Section 15 of the Act that suggestions or objections, if any, to the Commission's proposal to grant a transmission licence to the applicant, as aforesaid, be sent to the undersigned by **23.7.2024** at the above noted address. The suggestions or objections received after the specified date shall not be considered.
6. The application shall be taken up for the further hearing by the Commission on **25.7.2024**. Any person who files suggestions or objections may in his/her discretion attend the hearing, for which no TA/DA shall be paid by the Commission.
